### 申請成為會員 APPLICATION

- 凡支持本會宗旨及遵守本會憲章及附則的人士，均可親臨本會填寫會員申請表，提供身份證核對並繳交年費成為會員  
Persons who uphold the objectives of HKFWC and comply with the Constitution, By-laws and Rules of HKFWC can apply for membership. Eligible persons can fill in the application form in our centre, provide I.D. card for verification and pay the annual membership fee.
- 12-17 歲人士，須得家長或監護人同意，由家長或監護人陪同下申請  
Persons aged 12-17 must obtain parental consent to apply the membership. They have to register with the parents or guardian.
- 會員可獲發會員證，憑證於開放時間內享用中心設施及會員服務，及以會員優惠價參與活動  
Membership cards are issued. Members can use the facilities of HKFWC's service centres during the opening hours, enjoy membership services and join activities at membership prices by presenting their card.
- 凡合資格領取專上學生資助計劃（助學金）、綜合社會保障援助計劃、學生車船/學校書簿津貼計劃、在職家庭津貼計劃資助之人士，均可在出示證明文件後申請豁免會員年費，本會將於稍後通知申請人結果  
Any applicant, who is eligible to apply Financial Assistance Scheme for Post-secondary Students (Grants), Comprehensive Social Security Assistance, Student Travel Subsidy / School Textbook Assistance Scheme and Working Family Allowance Scheme, can apply for waiver of the annual membership fee after providing supporting document. HKFWC will notify the applicant once the result comes out.
- 會籍由申請當日起計，有效期 1 年  
Membership is valid for one year from the application date.

### 會員責任 OBLIGATIONS

- 以會員價報名參加活動或借用設施時，必須出示有效會員證  
Members must produce a valid membership card when applying for activities or booking facilities at membership prices.
- 會員證絕不可轉借他人，如有遺失，須盡快通知本會及繳費辦理補領手續  
Membership cards are non-transferrable. If lost, notify us as soon as possible and pay for a replacement.
- 個人資料若有更改，請盡快通知本會  
For any change of personal information, please notify HKFWC as soon as possible.
- 遵守本會守則，不可隨便開啟服務中心任何電器用品，如有損壞須照價賠償  
Members should comply with the rules and regulations of HKFWC. Members must not turn on any electronic devices of the service centres without permission, or have to pay the full price for any properties damaged.
- 過期還書，每 1 日每項罰款\$1 元，如有遺失損壞，須按價賠償，詳情可參閱圖書借閱守則  
A \$1 late penalty is charged per day for every overdue book. Items damaged or lost shall be indemnified accordingly. For details, please refer to the rules of the library.
- 凡進入本會服務中心，必須登記，以便統計  
Members should sign in upon entry of HKFWC's service centres for statistical purpose.
